

NOTICE

Pursuant to Amendment 94 of the Arkansas Constitution, Notice is hereby given to the public that the Independent Citizens Commission (“Commission”) is proposing to adjust the salaries for Arkansas’s Constitutional Officers of the Executive Department, members of the General Assembly, Justices, and Judges.

The Independent Citizens Commission was created through the adoption of Amendment 94 to the Arkansas Constitution in the November 2014 general election. This Amendment gives the Commission the power to propose and adjust the salaries of the officials listed below. Proposed salary adjustments are listed with the current salary listed first followed by the proposed adjustment salary.

Written and verbal public comments on the proposed salary adjustments will be accepted thirty (30) days from the publication of this notice and will be considered by the Independent Citizens Commission prior to any final decision on salary adjustments if received within that time period.
