**INDEPENDENT CITIZENS COMMISSION
OF ARKANSAS
SALARY ADJUSTMENT RESOLUTION
September 21, 2021**

WHEREAS, the Independent Citizens Commission (“Commission”) was established by the voters passage of Issue 3 on November 4, 2014; and

WHEREAS, Issue 3, now known as Amendment 94 of the Arkansas Constitution, directs the Commission to review and adjust as it deems necessary the salaries of elected constitutional officers of the executive department, members of the General Assembly, justices, judges, and prosecuting attorneys; and

WHEREAS, Amendment 94 provides that the Commission shall include in its considerations the overall economic conditions of State of Arkansas at the time; and

WHEREAS, on August 25, 2021, the Commission reviewed data including the overall economic condition of the State of Arkansas and on September 8, 2021, proposed certain adjustments to the salaries of elected justices, judges, and prosecuting judges resulting from that review; and


WHEREAS, the Commission has provided notice to the public of these proposed salary adjustments, made available to the public any data review by the Commission in determining the proposed salary adjustments, and afforded the public a reasonable opportunity to provide public comment on these proposed adjustments pursuant to Amendment 94; and therefore

BE IT RESOLVED, that effective ten (10) days from the filing of this Resolution with the Auditor of State, the annual salaries of the elected constitutional officers, members of the General Assembly, justices, judges, and prosecuting attorneys shall be as follows:






