Dear Commissioners:

I write this letter as the President of the Arkansas Judicial Council. Members of the Arkansas Judicial Council include our state's circuit court judges (126), judges of the Arkansas Court of Appeals (12), and Justices of the Arkansas Supreme Court (7).

I have been authorized by the Council's Board of Directors to request a cost-of-living adjustment for our state court judges. Governor Hutchinson granted a 2% wage increase for all state employees in February, citing record inflationary pressures due to the pandemic. In May, Governor Hutchinson also authorized state agencies to use an additional 5% of their total payroll costs for merit raises for employees, again citing the rising costs of living.

Over the last few years, the Commission has done an excellent job acknowledging the hard work of our state's judges. Judges and their staffs deal with difficult situations with individuals facing a variety of problems. We feel our response during the pandemic has been exemplary. We often put our own health at risk to ensure courts in our state remained open. Evidence of this includes our caseload clearance rate for all cases in 2021, which was 93%.

We thank you in advance for your fair consideration of our request.



In anticipation of the Independent Citizens Commission meeting presently scheduled for Friday, September 30, 2022, I have been authorized by the Prosecution Coordination Commission to request a cost of living/salary adjustment consistent with any salary adjustment awarded to Arkansas Circuit Judges.

When the Commission first considered salary adjustments for Arkansas Prosecuting Attorneys, a decision was made to set the salaries of Division A Prosecuting Attorneys at 95% of the salaries of Arkansas Circuit Judges. The salaries of Division B Prosecuting Attorneys were set at 85% of Division A salaries. It is our request that any adjustments continue to maintain these percentages.

A representative will attend the upcoming meeting and be available to answer questions and provide additional information. The Prosecution Coordination Commission thanks you for considering our proposal.
