### Notice of Proposal to Increase Salaries

On January 20, 2023, in accordance with the provisions of the Arkansas Constitution, Article 19, Section 31, the Arkansas Independent Citizens Commission, (ICC) reviewed the salaries paid to the incumbents of the following positions:

Governor  
Attorney General  
Treasurer of State  
Commissioner of State Lands


Lieutenant Governor  
Secretary of State  
Auditor of State  
Members of the General Assembly

The ICC examined the salaries authorized for these positions and considered the effect of inflation on these salaries. By a majority vote, The ICC proposes to increase the existing authorized annual salaries for the above specified positions computed by an increase of six percent (6%) per annum. If the ICC adopts such salary adjustments, they will become effective ten days after filing with the Auditor of State. A list of the present and proposed salaries is attached.

The ICC will consider this proposed adjustment on Friday, February 17, 2023, at 10:00 A.M. o'clock at Room 130, Arkansas State Capitol Building, 500 Woodlane, Little Rock, Arkansas. If said room is unavailable a notice of the change will be posted at the entrance of Room 130. Emailed public comments may be submitted to the ICC.
